## County Improvements for Roads and Bridges (CIRB)

- Projects are selected and updated by the counties and Circuit Engineering Districts (CEDs)
- Approved annually by the Transportation Commission
- The Plan is modified based on changes in county priorities, revised estimates, project readiness and other factors



## County Improvements for Roads and Bridges (CIRB)

- Only approved plan projects are eligible for funding
- CIRB funds are used to match \$34 million in federal funds allocated annually for county projects.
- CIRB funds are also used to match Tribal Nations funding on some projects



# Bridge Formula Program (BFP)SD City Bridges & Scour Mitigation

- Nearly \$57.6M per year for Oklahoma
- Minimum of 15% to off-system
- \$15M per year for scour mitigation (city & county)
- \$10M per year for city bridges
- \$3M per year for engineering

ODOT will invest \$140M on off-system bridges over the next 5 years



## Requirements for consideration:

- Must be structurally deficient
- Must be within city limits
- Must be 20' in length and have an NBI number





## **Notice of Interest**

- Not a guarantee of funding
- Considerations:
  - Is it load posted?
  - Is it a bus route
  - ADT
  - Population



# Municipal Road Drilling Activity Fund (MRDAF)

- Financial assistance to repair roads damaged by oilfield activities
- \$5M per year
- Population under 15,000
- 75/25 cost share (in-kind contribution not allowed)
- Applications open April 1st





## **Application**

- Contact information
- Population at 2020 census
- Road name & length of repair (ex.- Main St. 0.25 miles from 1<sup>st</sup> to 4<sup>th</sup>)
- ADT (average daily traffic), if known
- Is the road a designated truck/heavy traffic route?
- Estimated cost
- Map of oil activity within 5 miles
- Signed resolution



## **Transportation Alternative Program (TAP)**

Funded provided through the IIJA Bill - Competitive **Application Process** 

Safety Components of TAP

- ADA compliant sidewalks and trails
- Bicycle infrastructure
- Pedestrian and bicycle signals
- Traffic calming techniques
- Streetscapes or Enhancements





\$52 million in projects were awarded funding in 2022



#### ELIGIBLE APPLICANTS AND FUNDING CATEGORIES

- Governmental Entities
  - Local governments
  - Regional Transportation Authorities
  - Transit agencies
  - Natural resource or public lands agencies
  - School Districts, local education agencies or schools
  - Tribal governments
  - A metropolitan planning organization that serves an urbanized area with a population of 200,000 or fewer
  - A nonprofit entity.

- Anticipated Funding Categories
  - Under 5,000 (100% Design 90/10 Const.)
  - 5,000 49,999 (80/20 Design/Const.)
  - 50,000 200,000 (80/20 Design/Const.)
  - > 200,000 (ACOG and INCOG)(under 15,000 2020 population eligible to apply for statewide funding. All others will apply through ACOG or INCOG)



#### ELIGIBLE PROJECT ACTIVITIES

- Construction, planning, and design of on-road and off- or road facilities for pedestrians.
- Conversion and use of abandoned railroad corridors for trails for pedestrians, bicyclists, or other nonmotorized transportation users.
- Construction of turnouts, overlooks, and viewing areas.
- Community improvement activities, including:
  - inventory, control, or removal of outdoor advertising;
  - historic preservation and rehabilitation of historic transportation facilities;
  - vegetation management practices in transportation rights-of-way to improve roadway safety.

- Any environmental mitigation activity, including pollution prevention and pollution abatement activities and mitigation to:
  - stormwater management, control, and water pollution prevention
  - reduce vehicle-caused wildlife mortality
- The recreational trails program(NEW)
- The safe routes to school program: Infrastructure and Non-Infrastructure projects.
- Planning, designing, or constructing boulevards and other roadways largely in the right-of-way of former Interstate System routes or other divided highways.



### TAP PROCESS PRIOR TO AWARD

- TAP Projects are Awarded Through a Competitive Application Process
  - Current funding (fully allocated) is provided by the IIJA Bill.
  - During the application process, ODOT Local Government staff provides technical assistance and guidance
  - Applications are completed on-line
  - Application scoring criteria is provided in the Implementation Manual
  - Applications are scored by committee and recommended for award to the ODOT Senior Leadership and Transportation Commission
  - Transportation Commission awards projects at ODOT Commission Meeting

## HOW TO BE PREPARED FOR THE NEXT ROUND

- Create a plan
- Walking audit/walkability study
- Start coming up with a project description
- Design estimate (based on most current cost estimates)
- Build community support/Involve the public



## Access Roads – Industrial and Lake Access

- Purpose is to provide public access to lakes and recreation areas and industrial areas
- State funds
- Available to municipalities and counties
- Resurfacing only
- Work done at the local level



## **Emergency Relief Program**




- Must be a minimum of \$700,000 (federal share) in damage from event
- Provides assistance for emergency and permanent repairs
- Damage must be on a major collector road or higher
- Make sure damage is thoroughly documented before and after repairs are made
